

# Mizzi + (Plus) Loyalty Card

## Terms and Conditions

### General

Mizzi + (Plus) is a loyalty card programme operated by Mizzi Motors Ltd., (COMPANY), a company registered in Malta, and whose registered address is Muscats Motors, Rue D'Argens, Msida, Malta.

Members agree to have read and to abide by the terms and conditions set out below and other directives and/or regulations that may be issued from time to time and communicated to members and/or published on the COMPANY's website. (<http://www.mizziorganisation.com>)

These terms and conditions set out the relationship between members and the COMPANY.

These Consumer Terms may be varied only by the COMPANY and amendments to these Terms & Conditions may be made on the COMPANY'S website (<http://www.mizziorganisation.com>) from time to time.

### Membership Fees

Membership is free of charge.

### Eligibility

All Maltese citizens purchasers of vehicles as from 1st. January, 2008 from any of the following companies or their subsidiaries: Muscats Motors Limited, Continental Cars Ltd., Industrial Motors Ltd., and Nissan Malta Motors Sales Ltd. and have attained the age of at least 18 years are eligible to become card holders. The loyalty card will be issued to purchasers of new vehicles on delivery of the vehicle by filling in the appropriate application form. Vehicle owners who have already purchased their vehicle and are eligible for the card as per above can apply by filling in the appropriate application form, which form will be sent by post. It is also available on the website under the automotive section of the Mizzi Organisation website at <http://www.mizziorganisation.com>. Applicants will be notified of acceptance by the assignment and issuance of a membership card. The COMPANY has the right to refuse any applicant without the need to give any reason. The decision of the COMPANY will be final in this respect.

### Preferred Mailing Address

All correspondence will be sent to the member at the address indicated on the application form. The member is responsible for notifying us of any change of name, address or other details. The company cannot be held liable for any communication not received even though the address given is correct.

### Membership Cards

Mizzi+ membership cards are non-transferable and remain the property of the COMPANY at all times and the COMPANY reserves the right to request the return of the Mizzi+ membership cards on demand.

### Benefits

Authorised holders of the Mizzi+ loyalty card are eligible to receive benefits and rewards as specified from time to time by the Mizzi Motors either through direct communication or through its website. Benefits/ discounts offered to card holders cannot be combined with any other benefits/discounts or offers that the company may make to its customers either in general or to specific target groups.

## **Termination**

The COMPANY reserves the right to terminate a member's card at its absolute discretion. Any misuse of the card or breach of the conditions stated herein or on the COMPANY'S website may cause the immediate cancellation of membership and will have his card withdrawn.

A member has the right to cancel his membership at any time he deems fit.

## **Data Protection**

As per the Data Protection Act 2001 the COMPANY has a legal duty to respect and protect any personal information collected from you and will abide by such duty. It will take all safeguards necessary to prevent unauthorised access. Your data will only be used for the administration of the loyalty programme and for marketing purposes by the COMPANY, its associates and subsidiaries. By applying for the card, the applicant is giving his consent for his data to be used as described above.
